Please note that the bidders should comply with the following specifications:

Equipment and architecture

The system consists of the following equipment:

1. 170 Bosch DCNM-MMD2 delegate units installed at the delegate positions as well as a unit at the speaker's position, Support staff positions including the Sargent at Arms and the podium.
2. 6 Automatic cameras for the capturing of images of delegates addressing the chamber
3. A number of Monitors for the staff, including the speakers at the front podium
4. Recording connection points for the press gallery.
5. Connection points for the national broadcaster to connect into (installed in designated rooms)
6. Translation booths equipped with Bosch Dicentis interpretation units as well as monitors.
7. Connection to computers used for the recording of minutes for HANSARD
8. Control equipment in the control room to manage the system before and during a session.
9. Two 19" equipment racks installed into the control room for the housing of the headend equipment.
10. A large wall mounted screen for use of displaying presentations, as well as delegates which are addressing the sitting.

Pricing required for the following works to be attended to

The following faults have been identified which need to be quoted for and rectified.

1. Speech time settings for delegates and management thereof.
2. Connection points for the press to connect to for an audio feed in the galleries need attention to and tidying up.
3. Camera Positions and presets are not operating correctly
 - a. This due mainly to delegate units being moved from their original position without reprogramming the camera positions
 - b. The chamber cameras prepositions require reconfiguring.
4. Two of delegate units are faulty
 - a. These need to be replaced or repaired
5. The monitors on the speaker's podium obstruct the view of the chamber for those seated at the speaker's desk and support personal.
 - a. These need to either be replaced with more suitable monitors or repositioned not to obstruction the view of the chamber from these seating positions.
6. Some of the loudspeakers installed in strategic positions for audio coverage in the galleries and booths are not working, this need to be attended to.
7. The interpretation booth for the signing interpreters requires a monitor from where the interpreter can have full view of the delegate addressing the chamber.
8. The feed for the outside broadcaster needs to be undated for video and audio feeds.
9. An interface unit is required for interfacing the chamber audio and video feed for connection of delegates, who are not present in the chamber, through which they can connect to the chamber enabling them to participate in the matter at hand.
10. It is necessary to install a monitor and delegate unit into the interpretation booth for the signing interpretation.
11. The monitors installed in the other interpretation booths does not display the image on the Member addressing the chamber on the full screen, this needs to be rectified.

1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:
- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
 - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 To be completed by the organ of state

- a) The applicable preference point system for this tender is the 80/20 preference point system.
- b) Either the 80/20 preference point system will be applicable in this tender. The lowest/highest acceptable tender will be used to determine the accurate system once tenders are received.

- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 To be completed by the organ of state:

The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3.1. POINTS AWARDED FOR PRICE

 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favorable arrangements due to such cancellation.
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
